Risk Management Reminders

being a license renewal year, we will see a large number of licensees finally making a decision to take continuing education courses in the summer months. As advertised over the past year and a half, the Risk Management requirements have been changed. There are now two **Risk Management courses** that must be taken for a total of six hours. The remaining nine hours of the required 15 hours for active license renewal can be approved courses chosen by the licensee. Here is the explanation of the new requirements:

Rule 790-X-1-.11 of Alabama License Law was amended and now reads:

- 1) To meet continuing education requirements, licensees shall complete fifteen (15) clock hours each license period as set out below beginning October 1, 2012:
- (a) Three (3) clock hours in Risk Management Level 1. In this level, brokers and salespersons shall take the Risk Management: Avoiding Violations course.
- (b) Three (3) clock hours in Risk Management Level 2. In this level, all brokers shall take the Risk Management for Brokers course.
 Salespersons shall take the Risk Management for Salespersons course, the Risk Management for Brokers

course, or an industryspecific Risk Management course approved for Level 2 credit by the Commission.

(c) Nine (9) clock hours in Commission-approved courses

The following emblems represent the different Risk Management courses that are required. They can be located in the Instructor Resources area of the Commission's website. Feel free to use these for advertising and explaining the new Risk Management requirements. All licensees must have a Level 1 and Level 2 course for a total of six hours in order to satisfy license activation and renewal requirements.



LEVEL 1 for Risk Management includes the *Risk*

Management: Avoiding Violations course required for all licensees...both salespersons and brokers.



LEVEL 2 for Risk Management includes the *Risk*

Management for Brokers course which is required for all brokers...both associate and qualifying.



LEVEL 2 for Risk Management also includes the *Risk*

Management for Salespersons course and Risk Management courses in other areas approved by the Commission.

When teaching these Risk Management courses, keep



in mind that the course content deals only with managing the risks in the areas of real estate included in the outline. There is no need for a very detailed discussion of the topic which can lead to many questions resulting in the course

ending prior to all of the outline being covered. For example, if a student wants or needs a detailed explanation of contracts, he or she will need to take a course on contracts. The Risk Management course should only address the risks involved in the use of contracts. Please keep this in mind as you are preparing to teach a course and inform your students as well.



2014 REEA Conference

The 2014 Annual Conference of the Real Estate Educator's Association (REEA) will be held **June 20-23, 2014** in Scottsdale, Arizona. **Registration and hotel information is available on REEA's website at reea.org.**

On June 20, an IDW will be taught by Marie Spodek, DREI, and Theresa Bamabei. Prelicense Instructors who attend this IDW will receive six hours of instructor training toward the hours needed for the 2015 education renewal.

There will be numerous education sessions throughout the day on June 21 and June 22. Prelicense Instructors who attend all of the education sessions on both days will receive twelve hours of instructor training toward the hours needed for the 2015 education renewal.

Those who are seeking to become Prelicense/Post License Instructors will receive 5 points on their application for attending the IDW and 10 points for attending the education sessions

On June 23, the DREI Leadership Council will hold a session from 9:00 a.m. to 12:00 p.m. to discuss requirements for becoming a Distinguished Real Estate Instructor. This designation was designed by REEA to recognize excellence among real estate instructors and is awarded only to those REEA members who demonstrate outstanding knowledge of their profession, experience, and classroom performance. Currently, there are less than 70 active DREIs and none in Alabama. More information about the DREI designation is found on REEA's website.

AMP Examination Results



For all prelicense instructors who are interested in examination pass rates for students, you have access to that information through AMP's website at goamp.com. For an instructor to log in and see examination results, just select *Portals* at the top of the homepage and then

select School User. This will reveal the School User Login asking for username and password. If you have forgotten your login credentials, contact Ami Lucky at AMP as she is the best resource for school portal users. Ami's email address is ALucky@goamp.com.

There are two reports available on the portal: *Graduate Listing* and the *Alabama Real Estate - School Summary*. There is also the *News and Current Events* section which is periodically updated with new information.

Make use of this beneficial site to stay current with the performance of your students and all Alabama examinees.

Course Application & Reporting Reminders

Instructors and schools are reminded that Rule 790-X-1-.12(4) of Alabama License Law prohibits the advertisement of a course prior to the course being approved by the Real Estate Commission. This Rule also requires that the course application be submitted to the Commission at least 14 days prior to the proposed beginning date of the course. Instructors and schools are further reminded that section (5) of this Rule requires that courses be reported in CMap at least one week prior to the course offering.

The failure to follow the rules regarding course

applications could lead to serious consequences. First of all, the course may be denied if not submitted within the required time frame. Second, credit may be denied to those attending a CE course that was not properly set up in CMap at least one week prior to the course offering. Third, a formal complaint may be filed against a school administrator or instructor that habitually fails to follow the rules regarding courses.

Please make every effort to fully comply with Rule 790-X -1-.12(4) and (5). If you have any questions, please feel free to call the Education Division.

UESTION Is a Code of Ethics course required for license renewal?

No. The Code of Ethics course is required to be taken every four years to maintain membership in the National Association of REALTORS® (NAR). It is not required for license renewal. A licensee who takes a Code of Ethics course may receive continuing education credit if the course has been submitted to the Real Estate Commission for approval. The Commission does not give continuing education credit for the Code of Ethics online course that can be taken on the NAR website.
